

# Live Safe! Work Smart!

Health and safety e-news for Ontario teachers

## ? YOU ASKED US

**Q:** Does an employer have to provide WHMIS training if a WHMIS certificate has been earned at school?

**A:** Yes, if a worker is “exposed or likely to be exposed” to a WHMIS controlled product. An “exposed worker” may be a worker who stores, handles, uses or disposes of a controlled product, or who supervises another worker performing these activities. Exposure may occur during regular work activities, maintenance operations or emergency situations such as an accidental leak or spill.

Generic instruction on WHMIS is acceptable as a preliminary stage of instruction in a multi-stage instruction program.

Preliminary, generic instruction should include instruction in:

- content of supplier and workplace labels and material safety data sheets including WHMIS symbols,
- how WHMIS works,
- hazards associated with groups of products with similar properties,
- general work procedures for groups of products where the procedures are basically the same for all the products in the groups.

If generic instruction is provided in school, it is expected that there will also be on-site instruction provided by the employer in specific products, hazards and safe work procedures.
